Terms of Reference

(1) Position: Consultant (Kala-Azar) (State Level)

Reporting to State Programme Officer, Kala-Azar/Malaria. Place of Posting – State Health Society, Bihar, Patna No. of Position – 1 Category - Open

Qualification and Experience

 MBBS with Post Graduate degree in Preventive Social Medicine/ Community Medicine/ Public Health/ CHA And 1-2 years of experience preferably in public health programme/ Kala-azar programme implementation.

Responsibilities:

- 1. To assist the state in the development of state/district action plans.
- 2. To provide technical guidance pertaining with Kala-azar control programme.
- 3. To undertake field visits for at least 15 days in a month in endemic kala-azar PHCs & villages for supervision and monitoring.
- 4. To organize inter-sectoral coordination meetings, workshops, etc. with various stakeholders in the states.
- 5. To assist in organizing training programme for medical and para-medical and DDT spray workers.
- 6. To guide and assists state/districts in planning of Kala-azar Fortnights/ camps.
- 7. To formalize social mobilization opportunities (involvement of NGOs, FBOs, Private sector, PRIs and other stakeholders) for Kala-azar Elimination programme.
- 8. To assist state/districts in planning, developing, BCC strategies and its implementation in the state.
- 9. To verify compliance of treatment of kala-azar cases.
- 10. To facilitate the training programmes in the State/districts.
- 11. To assess the quality ad coverage under indoor residual spraying.

Deliverables:

Qualification and Experience

 Post Graduate degree in Commerce/MBA (Finance) or equivalent, And Minimum 2 years of experience in accounting, including analysis, financial reporting, budgeting, financial software and reporting systems.

Responsibilities:

- 1. To keep and maintain a separate account for the externally aided component (EAC) for state NVBDCP as per World Bank Financial guidelines.
- 2. To prepare monthly financial statements to be sent to NVBDCP to claim reimbursement.

- 3. To compile monthly account on the basis of monthly receipts and expenditure accounts received from various districts and headquarter.
- 4. To render financial advice to the project on all financial matters.
- 5. To coordinate with NVBDCP Headquarter on all financial matters.
- 6. To liaise with the State Health department in getting financial sanctions whenever required.

Qualification and Experience

 - 1. MBBS with Post Graduate degree/ diploma (such as MD/ MPH, DPH, MAE) And 1 year experience preferably in training in health sector.
 - 2. Post Graduate degree in the field of Life Sciences with 3 years experience preferably in training in health sector components.

Responsibilities:

- 1. To review the existing Kala-azar training modules available for state level functionaries and suggest improvements in collaboration with consultant training National level.
- 2. To review the current status of field training facilities, resources and capacity building needs.
- 3. To analysis the task and job responsibilities of the manpower to be trained.
- 4. To suggest the development of necessary skills to improve the competency of the trainee.
- 5. To assist in development of training modules for different categories at district and PHC level.
- 6. To keep liaison with other training institutions/ management institutions for specialized training on programme management at district and PHC level.
- 7. To assess the training workload and to make an implementation plan for training at district and PHC level.

Deliverables:

The Consultant will be required to submit a Monthly Activity Report to the State Programme Officer with a copy to Directorate of NVBDCP and a year ending Annual Report. Evaluation of performance will be done based on monthly activity report.

Eligibility Criteria

Qualification and Experience

- Post Graduate degree in Zoology (Entomology) or Life Sciences. For Life sciences candidate, Zoology as one of the subjects at graduate level is must.
- Experience of implementing vector control strategies.

Desirable:

• Minimum of 1 year's experience of working in a health program is desirable.

Duties and responsibilities:

Working as the assistant of the district VBDC Officer.

- 1. To ensure that current Programme Guidelines for planning, training, service provision, monitoring, supervision, and surveillance of Vector Borne diseases are applied in all health facilities and by all health workers concerned in the district.
- 2. To work with State and district-level officers to establish good practices of supportive supervision in the district for the control of vector borne diseases. Conduct regular field visits for ensuring quality implementation of the programme and provide technical support to the concerned staff on site, including ongoing on-the job training and supportive supervision of MTS/KTS.
- 3. To ensure timely data analysis, presentation and interpretation for VBD surveillance at district level.
- 4. To supervise the VBDC logistics so as to ensure against stock-outs.
- 5. To provide technical support to DMO and guide DMO, BMO and MTS for the preparation of district and sub-district plans for control of malaria and other vector borne diseases.
- 6. To supervise IRS micro-planning and implementation to ensure quality and coverage.
- 7. To actively seek involvement of District Collector, district administration NGOs, CBOs and the private sector (health and non-health) under various schemes.
- 8. To assist the DVBDCO/DMO and specialized staff in development of the BCC/IEC plan for the district with special emphasis on IPC tools and innovations in BCC/IEC.

<u>Tasks:</u>

- Visit all sentinel surveillance sites once of fortnight and 50% of PHCs in a month.
- Monthly advance tour program to be submitted to the DMO/CMO by 7th of the following month with a copy tp State.
- Maintain tour diary & Vehicle Log Book for each month.
- Participate in all district level & state level meeting held to review the situation of Vector Borne Diseases.
- Monthly Activity Report to State Programme Officer & Directorate, NVBDCP
- Preparation of Annual Report and action Plan on VBD.
- To supervise and monitor the activities of MTS/KTS And LTs in the district.
