Inviting application for various posts under National Programme for Health Care of the Elderly (NPHCE) to be appointed on contractual basis for Community Health Centres & District Hospitals at Rohtas, Vaishali, Muzaffarpur, East Champaran, West Champaran & Kaimur.

**A. For Community Health Centres under NPHCE**

**1. Job title: Rehabilitation Worker**

**No. of Position** – 6 (UR-03, EBC-01, SC-01 & BC-01)

**Essential Qualifications:**

- 1) 10+2 or equivalent qualification
- 2) One and half year certificate course of Multi Rehabilitation worker or Community Based Rehabilitation Worker from a recognized institute.
- 3) Registered as Rehabilitation Personnel under Rehabilitation Council of India Act 1992.

**Desirable:** At least 1 year relevant experience of working in a Hospital.

**Job requirements/responsibilities:**

- 1) To manage and follow up patients requiring physiotherapy services.
