General Instructions for counseling and documentation of RBSK

Document Verification Process

- 1. The procedure for counseling will include Verification / Scrutiny of document.
- 2. The mere inclusion of a candidate in the merit list would not entitle every candidate to present himself / herself for counseling.
- Asking a candidate to report for counseling does not mean that he/she will be shortlisted for selection. The actual selection will depend on the number of seats available and the ranking of the candidate in the merit list.
- 4. The Counseling session will be conducted at **Deep Narayan Regional Institute of Cooperative**Management (DNS-RICM), Near Shastri Nagar Police Station, Shastri Nagar, Patna.
- 5. The schedule will be displayed on official website and the recruitment specific websites of State Health Society Bihar.
- 6. The **physical presence** of the candidate for counseling is essential. There is no provision for proxy attendance by authorization.
- 7. The Candidate **should bring original documents** for verification and a copy of the Challan receipt as proof of payment of Application Fee.
- 8. Candidates will have to report for counseling at their own cost.
- 9. Canvassing directly or indirectly for allotment of seat or adjustment will disqualify the candidate for selection.
- 10. The claim of eligible candidate will be forfeited and candidate will not be considered for subsequent rounds in case of following:
 - a. If Candidate is absent at the time and date given to him / her
 - b. If the Candidate is found not to meet the advertised eligibility criteria.
- 11. Scrutiny/Verification of the Documents
 - a. The candidate should report by the assigned reporting time in the Counselling written test Admit Card, at counseling centre on scheduled date for completing the process of scrutiny/verification of original documents.
 - b. The attendance of the candidates present for Scrutiny/verification of documents will be recorded on the venue. If candidate fails to report by the assigned time, he/she will be considered as absent for counseling and his/her claim will not be entertained for selection process.
 - c. Once the attendance is recorded, candidate should not leave the Hall/Location for any reason unless they have completed the Verification/scrutiny of documents, or, have got special permission from the Counselling Process In-charge.
 - d. Verification/Scrutiny form should be signed by the Candidate. In the verification form candidates are required to specify **their preference for district** of posting (maximum of 5 preferences). However, the Society does not guarantee that all candidates will get posting locations based on their choice alone.
 - e. Candidates are requested to leave the venue immediately upon completion of Document Verification Process.

- f. During Document Verification, the identity of candidate will be verified with available data as well as government approved identity cards mentioned in the candidate reregistration form, the candidates' Hand writing will also be verified with written test OMR sheet. In case the identity on hand writing of candidate does not match, this will be treated as attempt of impersonation and the candidate will be disqualified from Selection process and legal action may be initiated.
- g. The provisional list for selection will be published once the entire counseling process is over. A separate record of wait-listed candidates will be maintained indicating Name of the Candidate, Merit Number & Waiting List Number.
- h. In case of any dispute in the matter of eligibility, identity, and hand writing test or any other technical grounds, the decision of the Document Verification Committee will be final and binding on the candidate.
