With reference to above subject matter, this is to inform you that we are receiving a lot of complain from the applicants related to various problems faced by them during filling the Re-registered Application Form. Some of the problems are as following which required to be solved out as early as possible:-

SL.	Problem faced by the Applicant	Solution of the problem to be given
(i)	<b>General:-</b> SMS and E-mail related to Regn. No. and Password not received by various applicants.	SMS and E-mail related to Registration No. and Password to be delivered to all the applicants on their mobile no and Email ID given earlier or provided by them at the email ID: <a href="mailto:support@shsbihar.in">support@shsbihar.in</a> but Registration No. must be verified.
(ii)	<b>General:-</b> Last date of filling up of Re-registered Application Form is mentioned as 20.05.2014 in the SMS/ Email, while it should be 28.05.2014 till 5.00 p.m.	Last date of filling up of Re-registered Application Form should be mentioned as 28.05.2014 till 5.00 p.m. However, it has clarified in the paper advertisement also.
(iii)	<b>Ayush Doctor:-</b> Column for Degree of BAMS/BHMS/BUMS is of only 4 Parts.	Column for Degree of BAMS/ BHMS/ BUMS should be of 5 Parts depending upon need of the candidate.




(iv)	<b>Ayush Doctor:-</b> There is no column for Pre-medical/Pre-Ayurved/Pre-Tibb.	It should be incorporated in Column of Intermediate that anyone of the following courses:- <b>Intermediate Or Pre-medical/Pre-Ayurved/Pre-Tibb</b> , be treated as Intermediate.
(v)	<b>Ayush Doctor:-</b> Some of the Applicants have reported that Permanent Registration No. of BAMS/BHMS/BUMS with Bihar Registration Board of any discipline is rejected by the software by giving message:- <b><u>Please enter Permanent Registration No.</u></b> and <b><u>Incorrect Registration No.</u></b> although the applicants have entered their Permanent Registration No. with Bihar Registration Board in the Re-registered Application Form.	The Permanent Registration No. with Bihar Registration Board of any discipline should be accepted during filling the Re-registered Application Form. Please rectify that the required digit of six should not be compulsory. Any No. of digits may be accepted.
(vi)	<b>Pharmacist:-</b> B. Pharma has 4 Parts and D. Pharma has 2 Parts, the applicants having done D.Pharma reported that after filling the marks of 2 Parts, the software is not accepting the Form.	This is also to be changed in software that the form should be accepted of all the applicants, whether they have done B. Pharma or D.Pharma, whether the course is of 2 years or 4 years.
(vii)	<b>ANM:-</b> Column for Diploma in Nursing is of 2 Parts.	Column for Diploma in Nursing should be of 2 Parts depending upon need of the candidate.
(viii)	<b>All Posts:-</b> The marks of all parts are not automatically totalled and percentage of marks is not calculated automatically.	It should be facilitated that the marks should be automatically totalled after filling up of marks of all parts and percentage of marks should also be calculated automatically.
(ix)	<b>General:-</b> Applicants are not getting reply of their email to support@shsbihar.in	Kindly try to reply all the emails received with regard to queries at the earliest. If find difficulty in resolving, please email to State Health Society Bihar.
