Call for Applications for- 6 Months Bridge Program (certificate) in Community Health for Ayurveda Practitioner/GNM/B.Sc Nursing under National Health Mission.

State Health Society, Bihar invites applications from candidates (Regular & Contractual employees)/Fresh Ayurvedic Doctor/GNM/BSc Nursing who are willing and enthusiastic to serve the community may apply for the 6-Months Bridge Program on "**Certificate in community Health for Ayurveda Practitioner/Nurses under National Health Mission**". This course is part of an initiative under the National Health Mission to Strengthen Sub-Centre as Health & Wellness Centres (H&WCs) for improved implementation of Public health programmes and to enable comprehensive primary health care service delivery, including disease prevention and health promotion. Candidates who successfully complete this course will be posted at these **Sub Centres/Health & Wellness Centres (H&WC's) as Community Health Officers (CHOs)** to lead a primary health with remuneration @ Rs. 25,000-40,000 per month subject to the approval of National Health Mission, Gol.

The program will be implemented through Indira Gandhi National Open University (IGNOU)

Note:-

- I. Eligible candidates may submit their applications online only at State Health Society Website **on or before 07th May, 2018.**
- II. All applications will be subjected to a screening process as per TOR and shortlisted candidates as per decision of State Health Society, Bihar will have to undergo written examination. The final selection will be based **on the marks obtained in written examination** and availability of vacancy as per reservation roster.
- III. Selection shall be subject to reservation policy of Govt. of Bihar.
- IV. As per provision, 10 years age relaxation to differently abled candidates will be admissible.
- V. Candidates applying under reserved category must have a copy of their caste certificate, issued by competent authority of Bihar.
- VI. All essential documents will be scrutinised before the day of admission.
- VII. All selected candidates will have to sign a bond to serve in sub centers for at least three years after posting at Health and Wellness Centres (H&WC).
- VIII. Please note that **01-01-2018** shall be reference/cut-off date for computing experience, age, qualification etc.
- IX. Centre for training will be "Sadar Hospital, Vaishali" and Nalanda" or any other Govt. Hospital to be accredited as PSU by IGNOU, total seat will be 60 (sixty) for Ayurveda & 30 (thirty) for Nurses. Number of Seats & Centres may be increase after approval of Gol.
