- To appear in the said examination candidates are advised to download their Admit Card from appropriate link available on www.statehealthsocietybihar.org or www.health.bih.nic.in from 11 Oct 2019 By using Application Number and Date of Birth (provided by candidate during the process of application)
- You are required to bring Admit Card along with Colour Passport size photo affixed thereon and currently valid photo identity proof in original. Please note that your name as appearing on the Admit Card (provided by candidate during the process of registration) should exactly match the name as appearing on the photo identity proof.
Female candidates who have changed Sur name post marriage must take special note of this. If there is any mismatch between the name indicated in the Admit Card and Photo Identity Proof, candidate will not be allowed to appear for the exam. In case of candidates who have changed their name will be allowed only if they produce Gazette notification/ marriage certificate/affidavit.
- Reporting in the examination centre will be 60 minutes earlier than the starting time of exam.
- Candidates will neither be allowed to enter the Venue after the Gate Closure Time (10 Minutes before Test Time) nor permitted to leave before the completion of Examination.
- Candidates are instructed not to wear Shoes. Only Slippers / Sandals with low heels will be allowed.
- Use of books, notebooks, calculators, watch, pagers, mobile phones etc. is not permitted in this examination. Candidates are advised not to bring any of the banned items including mobile phones/pagers to the venue of examination as safety arrangement cannot be assured. Any candidate found resorting to any unfair means or malpractice or any misconduct while appearing for the examination including giving/receiving help to/from any candidate during the examination will be disqualified. The candidate should be vigilant to ensure that no other candidate is able to copy from his/her answers.
- Candidates are called for the Computer based Test without verifying your personal details viz age, qualification, Experience etc. with your certificates. Candidate must ensure that they fulfil the eligibility criteria stipulated by BSSS (ABPMJAY) in all respects. At any point of time BSSS finds any discrepancy in candidature it reserves the right to cancel the candidature. In this regard decision taken by BSSS will be the final and shall have to be accepted by the candidate.

9. **Any request for Centre change/ date change will NOT be entertained.**
10. Any canvassing by or on behalf of the candidates or any other outside influence with regard to their selection/recruitment shall be considered as DISQUALIFICATION.
11. The possibility of occurrence of some problem in the administration of the examination cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problem, which may include movement of candidates, delay in test. Conduct of a re-exam is at the absolute discretion of test conducting body. Candidates will not have any claim for a re-test. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.

Anyone found to be disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of test contents in any form or any information therein in whole or part thereof or by any means verbal or written, electronic or mechanical or taking away the papers supplied in the examination hall or found to be in unauthorized possession of test content is likely to be prosecuted.
